1. Notice

RCCG Inspiration House is committed to protecting your privacy. This Privacy Notice explains what to expect when we collect and use your personal information. 2. Scope

All data subjects whose data is processed by RCCG Inspiration House.

3. Responsibilities

Our responsibility is to ensure that this notice is made available to potential data subjects prior to collecting/processing their personal data.

All RCCG Inspiration House staff who interact with data subjects are responsible for ensuring that this notice is drawn to the data subject's attention, and their consent to the processing of their data is secured.

4. Our Privacy Promise

- RCCG Inspiration House is committed to respecting your privacy and ensuring the personal information you have entrusted to us is held securely and used for the specific purpose.
- Your personal information is processed in accordance with the European Union's General Data Protection Regulation (GDPR) May 2018. The GDPR strengthens your rights to privacy and gives you control over the personal information that organisations hold about you.

6. Fair Processing Notice

What is Personal Data?

Under the EU's General Data Protection Regulation:

Personal Data is defined as "any information relating to an identified or identifiable natural person ('data subject'). An identifiable natural person is one who can be identified, directly or indirectly; in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person".

The Personal Information We Collect:

- Personal identifiers such as your title, name and day and month of birth;
- Contact details including postal address, postcode, email and telephone number;
- Bank details and whether you are a UK taxpayer, when you make a donation, using your card or bank transfer; information such as your
- Spouse, Children, when you are registering for some of our events as required.
- Letters you write to Inspiration House;
- Records of your contact with us.

Sensitive Personal Data

- The Data Protection Act recognises some information as 'sensitive personal data'. This includes, but is not limited to, information which reveals your religious beliefs, medical history, race or ethnic origin.
- RCCG Inspiration House is a Church committed to preserving its Christian ethos and its beliefs in accordance with our statement of faith (further details are available on our website <http://www.rccginspirationhouse.church>). Where necessary and consented to, we may collect details about your personal faith.
- Additionally, we collect details about any health concerns or disability you disclose so we can meet your needs better.
- As a praying church, we may share and pray for any prayer request you disclose to us, at our internal prayer sessions. You may choose to remain anonymous.
- We will always treat any sensitive personal data we process with great care and process the information in accordance with the Data Protection Act.

3. Why We Collect Your Personal Information

- To carry out our primary objective; which is to advance the Christian Faith and the Relief of Poverty.
- To keep you informed in real time about our church programmes and activities both internal and national.
- You may also get a notification on prayer and fasting programmes, notification on consultations that affect the Christian faith, notification of other events on the Christian calendar globally.
- To reclaim tax on Gift Aid donations, if applicable.
- To verify that you are over 18 and if not, obtain permission from your parent/guardian to process your information or accept any regular donations.
- When you visit our website, we may gather information about which pages you visit to help us improve and provide you with the best service.
- To determine and improve the effectiveness of our website and publicity campaigns. Please see more details in the [Marketing Permissions section](#).
- To enable us to contact you with relevant and the most appropriate information.
- To manage and coordinate our volunteers.
- For compliance with employment law and other statutory requirements.

How RCCG Inspiration House uses your information

- RCCG Inspiration House will process – that means collect, store and use – the information you provide in a manner that is compliant with the EU's General Data Protection Regulation (GDPR).
- We will endeavour to keep your information accurate and up to date and not keep it for longer than is necessary. In some instances, the law sets the length of time information has to be kept, but in most cases, RCCG Inspiration House will use its discretion to ensure that we do not keep records outside of our normal business requirements.
- We will never sell, distribute or provide your sensitive personal information to third parties; we will only do so once we have obtained your consent, unless we are legally required to do so.
- We may pass your personal data on to our service providers who are contracted to RCCG Inspiration House in the course of dealing with you. Our contractors are obliged to keep your details securely and use them only to fulfil the service they provide you on our behalf such as registration or payment processing. Once your service needs has been satisfied, or the case has been closed, they will dispose of the details in line with our record retention procedures.

Marketing Permissions

- We love sharing news about what God is doing through the Church and the resources including events organised to advance our primary objectives. This includes sending you information about our work, news, events, information on volunteering and prayer requests.

- Email and text marketing:

We will ask for your permission to contact you by email or text for marketing purposes.

- Postal marketing:

From time to time we may send you information about our work unless you have told us you would prefer not to receive this information by post. If you have registered with the Mail Preference Service (MPS), we will only send you marketing communication by post if you have given us permission to do so.

- Telephone marketing:

We may call to update you on the vital work we are doing. If you have registered your number with the Telephone Preference Service (TPS), we will only make marketing calls to you if you have given us permission to do so.

- By consenting to this, you are giving us permission to perform those actions.

Who We Share Your Information With

• RCCG Inspiration House is part of the global RCCG family with presence in over 190 countries both inside the European Union and outside the European Economic Area (EEA). We will only share personal information as is necessary to fulfil our administrative needs.

• RCCG Inspiration House is committed to ensuring that where data is to be transferred overseas, adequate level of data protection safeguards when processing your personal information are in place.

• We may share your personal information with trusted third parties where they are contracted to develop or maintain our systems.

• We monitor information security compliance and have written contracts which obligate our partners or third-party providers to process your personal information only on our instructions and in accordance with applicable data protection and privacy laws.

• RCCG Inspiration House and any of its affiliate entities may be under a duty to disclose your personal information where required in order to comply with any legal obligation.

How Long We Keep Your Data

RCCG Inspiration House will only keep your personal information for as long as it is required and in accordance with statutory requirements. For example, HMRC requires that we keep a record of your name, address and Gift Aid declaration for six years. Where the information is no longer required, we will ensure that it is disposed in a secure manner.

Your Information Rights and Choices

The Data Protection Act (DPA) gives you the right to:

• Request in writing and securely obtain copies of the personal information RCCG Inspiration House holds about you

• Correct or update your personal information processed by RCCG Inspiration House

• Request RCCG Inspiration House to stop using your personal information for marketing purposes or for any other purpose where there is no legal requirement for continued processing.

The Privacy and Electronic Communications Regulations (PECR) gives you the right to:

• Choose whether or not to receive marketing communication from us by email, text or telephone. Please see the Marketing Permissions section for more information about how to change or update your contact permissions and preferences.

• To know about the cookies, RCCG Inspiration House uses so that you can decide whether to give us permission to store a cookie on your device. Please see the Cookies section for more information.

Cookies

Cookies are small text files that are placed on your computer by websites that you visit. RCCG Inspiration House uses cookies to enable our website to function effectively, to improve your experience and to determine and improve the effectiveness of our website and marketing campaigns.

Here is a brief overview of the types of cookies we use on our websites:

- We may use both 'session' cookies and 'persistent' cookies on the website. We will use the session cookies to keep track of you whilst you navigate the website; and for other reasonable uses. We will use the persistent cookies to: enable our website to recognise you when you visit
- Session cookies will be deleted from your computer when you close your browser. Persistent cookies will remain stored on your computer until deleted, or until they reach a specified expiry date
- We use Google Analytics to analyse the use of this website. Google Analytics generates statistical and other information about website use by means of cookies, which are stored on users' computers. The information generated relating to our website is used to create reports about the use of the website. Google will store this
- We publish Google AdSense interest-based advertisements on our website. These are tailored by Google to reflect your interests. To determine your interests, Google will track your behaviour across the web using cookies. You can view, delete or add interest categories associated with your browser using Google's Ads Preference Manager, available at <http://www.google.com/ads/preferences/>. You can opt-out of the AdSense partner network cookie at http://www.google.com/privacy_ads.html.
